


A personal interview, background check and twenty (20) hours of training are required before beginning work as a facilitator. A facilitator's time commitment is two weekday evenings per month from 5:30 p.m. to 9:30 p.m. on a set schedule. In order to establish consistency and continuity in support of our children and their families, a minimum one-year service commitment is required for group facilitators.
- * Spanish Speaking Peer Support Group Facilitators: We are seeking Spanish speaking facilitators for our support groups for children and their grieving families. The requirements are the same as those for the peer support group facilitators.
- * Houseparent Teams: Houseparents assist with setup, cleanup and serving pizza to the families who attend our peer support group sessions. Additionally, houseparents clean and organize the Volcano and Quiet rooms. Houseparents commit to serving once a month from 5:30 p.m. to 7:30 p.m. and are trained on the job. Houseparent teams are essential to the continuity of the organization.
- * Camp Facilitators: Facilitate weekend camps, Camp Good Grief (summer), Teen Retreat (spring), or Family Camp (fall). Facilitators agree to attend the entire weekend. A personal interview, background check and one day of training are required.
